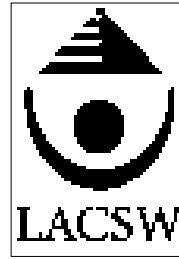

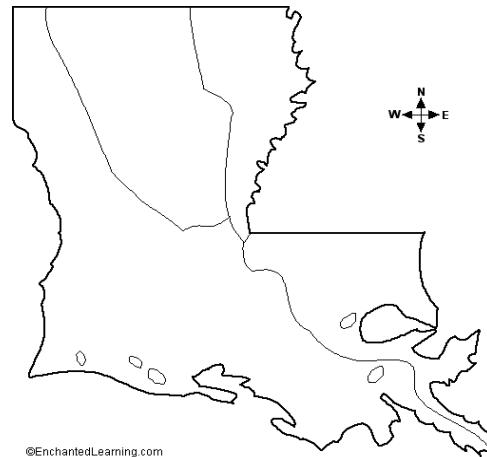
What an incredibly busy month for LACSW!!

In May, we hosted 2 outstanding workshops. On May 9th and 10th, our LACSW member abroad, Laury Bourgeois presented a supervision and ethics workshop for continuing and newly applying BACS, Many thanks to River Oaks to hosting the event.

Then May 22nd through May 25th, Peggy Pace returned to Louisiana to present her Life Span Integration approach to psychotherapy. She presented again the beginning workshop and for the first time in our area, the advanced training. Many thanks to our hardworking education committee and especially to the chair, Myra Hidalgo.

on us will be our June annual membership meeting and workshop. This year we are pleased to offer two 3 hour trainings: Understanding Eating Disorders from Origin to Recovery, Lauren Langley, Therapist, The New Orleans Institute, River Oaks Hospital and Trauma Based Sexual Compulsivity Myths, Dynamics, and Treatment, Dawn Diermann Treigle, Program Administrator, The New Orleans Institute, River Oaks Hospital.

On a different note, hats off to our legislative com-

mittee and its chair, past president Judith Haspel and our lobbyist Maxine Cormier. They have been working hard to protect our right to practice. HB 1345 looked like it would threaten social workers ability to practice substance abuse treatment (see more on this in the legislative report on page 2),and we continue to push for funding of the Medicaid proposal to allow LCSWs in private practice be paid by Medicaid for therapy.

# Legislative Report 2008

The legislative season began with the usual flurry of activity, with many volunteers reading up to a dozen bills. Thanks to everyone who contributed to this process. There were several bills we followed, but seemingly nothing that would threaten our ability to practice. However, the bill that caused concern, HB 1345, was submitted later in the season and created much unease.

HB 1345 was presented by the Department of Addictive Disorders and Don Hidalgo, and was introduced by Rep. Smith. This bill in its original form substantively expanded addiction counselors' area of practice to include "psychotherapy" and "diagnosis." Also of concern was the idea that perhaps they intended to exclude clinical social workers from substance abuse practice.

LACSW represented by Justin Schleis, Anita Evans, and me attended a meeting to which we were invited by Carmen Weisner of NASW. We discussed with Bob Sawyer of the Department of Addictions and Don Hidalgo, president of the Addictions Board, various aspects of their bill. Our primary purpose was to insure that their language would not preclude social workers from doing substance abuse work. They also agreed to limit their practice of diagnosis to only pertain to addictions. Although we were concerned about their practicing "psychotherapy" as we understand it, we did not alter that language.

Problems arose after the meeting when NASW and LACSW's leadership rethought the process. We also learned that the LPCs, Psychologists, and NASW wanted to oppose the bill in its entirety. We joined them in a united front and Debbie Fernandez testified at the Health and Welfare committee meeting on May 25, 2008 as did Carmen and someone representing the LPC's.

The bill was unanimously, involuntarily deferred by the committee. This means that even though the people who proposed the bill did not want the bill to die, they said they were not going to take any more action on it this year. We are grateful to Carmen Wiesner and NASW for their support, and to Maxine Cormier, our lobbyist, for her wisdom and guidance. Thanks to Justin, Anita, and Deb for coming through when we needed them most. What makes this organization so great is the people in it and when there is a problem to be fixed, the clinical social workers show up.

Many of us have worked with addictions counselors whom we respect and trust. We anticipate that next year this bill or one very much like it will resurface. Our hope is that we can work out our differences in a collegial way and that there will be greater understanding of one another's positions. However, we do have to be prepared for a potentially adversarial event and have more trust in ourselves than in other potentially competing disciplines.

If anyone is at all interested in joining the legislative committee, please let us know. Your participation can range from screening a few bills to actually going to the legislature. With many participants, no task in and of itself is overwhelming. People who join us feeling unskilled soon find that he or she has much to offer. The exchange of ideas is stimulating and participating in the legislative process is fascinating.

Go to <http://www.us.gov> to get all your contact information for your governmental officials.. (Well, you also need to know your zip code, but hey, you've gotta do SOME of the work!) But that one web address is all you have to remember.....

By going to that one web site [www.us.gov](http://www.us.gov) you can "follow the bread crumbs" and find the contact information for any and all government officials. For example, if you were wanting to know A) Who Is My N.C. Representative? and B) How do I contact her/him? you would begin by double-clicking on "state governments" on the home page of [www.us.gov](http://www.us.gov) and then (see below) putting in your zip code plus four and "following the bread crumbs." The same general principles apply whether you are looking up state or federal Senators, or anyone else.

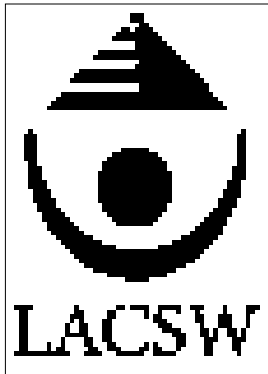
